**PRODUCT DESCRIPTION:**

The concentrate is prepared from depectinized, filtered juice derived from properly matured, cleaned cranberries (Genus/species, *Vaccinium macrocarpon*). It is concentrated under low temperatures and vacuum, and the essence fraction is returned. Processing conforms to all provisions of the Food, Drug and Cosmetic Act and the Code of Federal Regulations, Title 21, Part 110, current Good Manufacturing Practices, and Part 120, Juice HACCP. This ingredient has received a heat treatment sufficient to yield a 5-log pathogen reduction.

## **PACKAGING**

### **UPC 94040**

Packed in 55 gallon open head drums, filled to 50 gallons. Product contained within a 2 mil (minimum) polyethylene liner sealed with a plastic tie, placed within a 10 mil polyethylene liner. For security, the drums are sealed with a tamper proof multilock seal. Drums and lids contain no bungholes.

All containers shall bear the following information: name of product, UPC, net contents, Ocean Spray® name and address, °Brix, pack date, best before date (month/day/year), lot number, drum number, product of USA and/or Canada, and Circle U (for Kosher), Halal – crescent M.
